**PERFORMANCE BOND AND ENTRY FEES:**

- Wyoming's entries into FWR and the Presidents' Cup are fully determined by club responses, which must be in the state office no later than **FEBRUARY 15, 2010**.
- Clubs must submit a performance bond for each committed team.
  - Bond checks for teams that advance will be returned once the team's entry fee has been received.
  - WYS pays \$250 of each FWR entry fee and \$100 of each Presidents' Cup entry fee.
  - Bond checks are returned to teams who do not advance to either event.
- The bond will be forfeited by any club/team that, after committing, fails to enter the Wyoming State Cup or that, after winning the state championship or state runner up, does not participate in the FWR or President's Cup tournament.

**UNCONTESTED TEAMS:**

- If only 1 (one) team in an age bracket commits, pays the bond by the deadline, and chooses to accept the uncontested championship the team can advance to either the FWR or the Pres' Cup. Uncontested teams must notify the state office of their decision by **FEBRUARY 19, 2010**.
- No additional teams will be allowed to enter uncontested brackets.
- Uncontested teams will be contacted and allowed to withdraw.
- An uncontested team that chooses to enter the Pres' Cup will not be named the Wyoming State Champion.
- Uncontested teams do not have to enter the Memorial weekend tournament **but will** be assessed a minimum \$150 administration/entry fee.

**CONTESTED TEAMS:**

- If 2 (two) or more teams in an age group commit and pay the bond by the deadline, additional teams in that age group will be allowed to enter as long as they do so by the state cup entry deadline.
- If no more than 2 (two) teams enter into the U15 or up age group they can, upon agreement of the team coaches and the WYS executive board, play their championship games anytime, but not later than June 7, 2010.
  - Those teams must arrange for USSF referees to officiate.

**We cannot add teams after Region IV tournament entry deadlines nor remove teams without penalties.**
